IN MARINE ENVIRONMENTS ARTICLE SHOULD BE WEEKLY WHASED WITH FRESH WATER. WE WOULD ADVISE USING GOLDEN CARE PRODUCTS AS THEY ARE SPECIALLY DESIGNED FOR CLEANING METAL, GLASS AND SYNTHETIC FIBRES. WOOD COLOUR CHANGES MAY OCCUR AFTER SOME TIME DUE TO EXPOSURE TO SUNLIGHT. THIS PRODUCT "FEARS" HEAT SOURCES AND TOO MUCH HUMIDITY, THEREFORE PAY ATTENTION WHERE YOU PLACE IT.
