




BACK CUSHIONS: 100% SPIRAL SILICON POLYESTER FIBER PADDING WITH OUTSIDE MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER.

OPTIONAL HEADREST: 100% SPIRAL SILICON POLYESTER FIBER PADDING WITH OUTSIDE MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER.
