MODULAR SOFA REMOVABLE - ARMCHAIR



STRUCTURAL COMPONENTS

OUTDOOR MODULAR SOFA

Aluminium structure with Ceramic or HPL top. Also available with Iroko structure and with HPL, Ceramic or Iroko top. Fabric seats with Dryfeel foam for outdoor use and silicone polyester fibre cushions. Hand-woven backrests and armrests in powder-coated aluminium. Once the individual elements are combined and attached together, the size of the composition may vary by a few centimetres compared to the dimensions indicated in the price list. Available with the standard «REGULAR ADJUSTABLE» leg, thanks to which the sofa reaches a seat height of 43/45 cm. If required, it is possible to have the optional «HIGH COMFORT ADJUSTABLE» leg in addition to the standard «REGULAR ADJUSTABLE» leg, whose height of 24 cm allows the sofa seat height to be raised up to **47/49 cm**.

SEAT: QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + RESIN POLYESTER FIBER, WITH OUTSIDE TOP MESH IN POLYESTER AND OUTSIDE BOTTOM MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER

BACK CUSHION: QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + RESINATED POLYESTER FIBER. CUSHION COVER REMOVABLE.

OUFFIT COVER: The covers are suitable for the protection against the atmospheric agents. They are custom-made pieces according to the sofa composition chosen by the customer. Sofa and covering are produced at the same time and are composed 50% of polyester + 50% of polyurethane fabrics, with a density of 190 gram per square meter. The polyester fabric is light-grey and has one side of acrylic resin coating, which makes the fabric water and oil proof. These coverings have been designed and created to resist the direct water passage according to the technical standard UNI-EN-ISO 811, the water permeability and the water column test higher than 1000 mm.
