SEAT: QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES. REMOVABLE CUSHION COVER.

CUSHION: 100% SPIRAL SILICON POLYESTER FIBER PADDING WITH OUTSIDE MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER.
