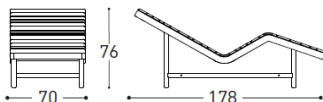

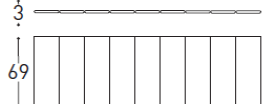

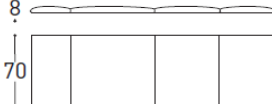

TEAK SUNLOUNGER.

**ECO:** QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES. CUSHION COVER NOT REMOVABLE.

**LUX:** QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + SPIRAL SILICON POLYESTER FIBER WITH OUTSIDE POLYPROPYLENE MESH. REMOVABLE CUSHION COVER.
