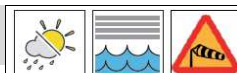

### STRUCTURAL COMPONENTS

MOKA ALUMINIUM FRAME WITH POLYESTER CURTAINS. HOT GALVANISED STEEL BASE, POWDER COATED AND READY FOR FIXING TO THE GROUND. DARK GREY COVER INCLUDED. COVER: ECRU POLYESTERS.

### PRECAUTIONS

THE FIXED SHADE STRUCTURES MUST BE ASSEMBLED CORRECTLY, RESPECTING THE ASSEMBLY INSTRUCTIONS. THE STATIC CALCULATIONS REGARDING THE BASE WEIGHTS AND THE WEIGHT OF THE STRUCTURE HAVE BEEN CALCULATED ON COMPLETELY EVEN FLOOR OR GROUND AS THE STRUCTURE NEEDS TO BE FIXED TO THE FLOOR TO OBTAIN THE MAXIMUM STABILITY FOR SAFETY. WITH EVEN A SLIGHT UNEVEN FLOOR, THE INFORMATION IS NO LONGER APPLICABLE AND WILL IN EFFECT MAKE THE STRUCTURE DANGEROUS. IT IS FUNDAMENTAL THAT STRUCTURES REMAIN OPEN WHEN USED AND WITH STABLE METEOROLOGIC CONDITIONS. IN CASE OF STRONG WINDS, SNOW AND UNAPPROPRIATE WEATHER CONDITIONS, CLOSE IMMEDIATELY AND BLOCK WITH THE APPROPRIATE RIBBONS . IMPROPER USE OF THE UMBRELLA STRUCTURE IS NOT ALLOWED.

### INSTRUCTIONS FOR USING THE PRODUCT PROPERLY AND SAFELY

VARASCHIN IS NOT LIABLE FOR DAMAGE CAUSED BY IMPROPER USE. IT IS ESSENTIAL TO BEAR IN MIND THAT THE SUNSHADE IS NOT A STRUCTURE FIXED TO THE GROUND AND IS THEREFORE TO BE KEPT OPEN ONLY WHEN IN USE AND GUARDED. IN THE EVENT OF STRONG WINDS, SNOW OR UNSUITABLE WEATHER CONDITIONS, KEEP CLOSED. IF THE GAZEBO IS NOT FIXED TO THE GROUND (IT IS DESIGNED FOR FIXING) IT CANNOT BE SAID WHAT TYPE OF WEATHER CONDITIONS WILL COMPROMISE ITS STABILITY.

### GENERAL INSTRUCTIONS FOR MAINTENANCE AND CLEANING

FOR DAILY CLEANING USE A DRY COTTON CLOTH. FOR MORE THOROUGH CLEANING USE ONLY A NEUTRAL PRODUCT DILUTED IN WARM WATER. NEVER USE ALCOHOL, AMMONIUM, THINNERS OR ABRASIVE PRODUCTS. IN MARINE ENVIRONMENTS ARTICLE SHOULD BE WEEKLY WHASED WITH FRESH WATER. WE WOULD ADVISE USING GOLDEN CARE PRODUCTS AS THEY ARE SPECIALLY DESIGNED FOR CLEANING METAL, GLASS AND SYNTHETIC FIBRES. FOR CLEANING AND TAKING CARE OF FABRICS, SEE THE VARASCHIN SPA "FABRICS" FOLDER.
